**Datuk Dr Anis Yusal Yusoff** is the Director of Centre for Leadership & Professional Development (UMLEAD), University Malaya. Previously he was the Deputy Director General of the National Centre for Governance, Integrity and Anti-Corruption (GIACC) and now a Principal Fellow at the Institute of Ethnic Studies (KITA), UKM. He has served over ten years at The United Nations Development Programme (UNDP) as well as at the United Nations Volunteers (UNV) Head Quarters in Bonn, Germany. In addition to his academic research work, Dr. Anis has served on a number of national advisory councils, including the Advisory Panel for the Consultation and Prevention of Corruption under the Malaysian Anti-Corruption Commission. He was also an advisory member of the panel for the National Advisory Consumer Council and the National Unity and Integration Training Institute. Dr. Anis was recently appointed by the King as Commissioner of the Enforcement Agency Integrity Commission (EAIC). Dr. Anis has been speaking and writing on issues related to people and development. His research and writings have been published as chapters in books, and as articles in a number of journals and newspapers. He is also regularly invited by the national media as an analyst of Malaysian socio-politics to discuss areas related to corruption, money politics and ethnic relations
